- 1. 2. **BALANCE SALE VALUE** should be paid through RTGS/NEFT in favour of Auctioneer **M/S EGBERT ANDREWS AUCTION MART** by the purchaser within 17 (Seventeen) days from the date of confirmation of lots of online auction by the auctioneer.
3. **GST** as applicable is to be deposited by the purchaser **under Reverse Charge Mechanism** and **receipt to be produced to the auctioneer along with balance sale value. GST validity proof should be sent to Auctioneer in advance.**

**CBIC Notification** : “Pursuant to issuance of CBIC Notification No. 25/2024-Central Tax dated 09.10.2024, it may be noted that necessary compliance for the payment relating to Tax Deduction at Source under Section 51 of the CGST Act, 2017 on metal scrap, wherever applicable, is to be dealt directly by the Buyer with Seller. TDS at the rate of 2% under GST is applicable only when seller and buyer are both registered under GST as regular taxpayer. Since GST TDS is a compliance matter pertaining to the buyer & seller only, Egbert Andrews Auction Mart as a Service Provider will not intervene in the matter. Accordingly, the payment is to be done as per the Payment Schedule mentioned in the auction catalogue.”

**DEFAULT IN PAYMENT** : In case buyers fail to deposit the balance sale value with necessary GST within stipulated period of 17 days a late deposit penalty @ 10% of 1% per day will be levied on total due mount & is to be deposited with auctioneer with total due amount prior to issue of SRO & lifting of lot/lots.

4. **Sale Release Order will be issued by the Auctioneer from the date of realisation of full payment (full sale proceeds & penalty if any). Proof of GST payment is to be submitted by the purchaser to the auctioneer.**
5. **Delivery** should be taken by the purchaser ex-site and within 30 (Thirty) days from the date of issue of Sale Release Order by the auctioneer, beyond which further 15 days may be allowed on permission from DGAR on payment of ground rent @ 10% of 1% per day of default on the sale value of said lot/lots. **On expiry of 45 days no further extension will be granted**, the amount deposited will be forfeited to Govt and lot/lots will be merged in Depot stock. In such circumstances the deposited value and the goods sold will become the property of Govt of India.
5. **Lifting of sold lots.** For lifting of sold lot/lots through an authorized representative, the concerned successful bidders must submit 2 representatives (lifters) name with attesting their signature in authority letter to the auctioneer. Such authorized representatives of the concerned purchasers will only be allowed to lift the lot/lots from respective MGARS/Units.
