The Pre Bid **Rs.2,00,000/-** (Rupees Two Lac Only) **by RTGS/NEFT** should be deposited by intending registered bidders with **Egbert Andrews Auction Mart, 161, Lenin Sarani, Kolkata-13 on or before 9<sup>th</sup> September 2025** after which pre bid amount will not be accepted. The Pre bid amount in respect of unsuccessful bidders will be returned after completion of the online e-auction.

1. **25%** of the sale value of the accepted bid/bids should be paid **online by RTGS/NEFT** by the successful purchaser as earnest money to the auctioneer within 7 (Seven) days from the date of issue of acceptance letter by auctioneer.
