- 1. EARNEST MONEY: 20%** of the sale value of the accepted bid/bids kept open for acceptance should be paid by the successful purchaser **online by RTGS/NEFT** as earnest money to the auctioneer within 7 (Seven) days from the date of confirmation by auctioneer on completion of online e-auction. Failure to deposit the 20% earnest money within scheduled time registration cancellation/debarring for at least 6 months & forfeiture action will be taken against the back out bidder by auctioneer.
